FROM THE PRESIDENT & EXECUTIVE DIRECTOR

Dear Members and Partners,

We live in a time where pivotal events are taking place and the future is not set in stone. This can be frightening when thinking of the effects of dwindling resources and an ever-expanding population. But it also means there is opportunity to help shape the future. For most of us, our largest impact is local – and fortunately conserving local lands is exactly what we all do as members, volunteers, staff, board and partners of Skagit Land Trust.

Our perspective at the Trust has always been to take the long view. We encourage you to view the Annual Report through this lens. When we select lands to conserve, we ask ourselves, how will this land add to the community now and in 100 years? Of course we can't predict 100 years out, but we can look at history and surmise a few things: Desirable urban areas around the world have



substantial open space in them and surrounding them; We can't save wildlife without saving the land wildlife lives on; Land conservation is not a luxury – it provides society with many lifesustaining resources such as clean air and water and life support systems for food and fiber.

The heart of our mission is *Protect the Best First*. Protecting special places today is a no brainer. It also makes good business sense since it's a lot more cost effective to protect these places now, than to restore them 30 years from now. We also conserve some diamonds in the rough. These lands aren't in the best of natural shape, yet could be and are needed for the big picture. We are grateful to our stewards and volunteers who look after our lands and help to restore the ones in need. Volunteers and wonderful partnerships, such as the one we had this past year with The Washington Trails Association, also make key

conservation areas accessible. We are pleased to say that of the hundreds of volunteer photos we had to choose from, there was not one sad or mad face... some muddy faces, yes.

Our financials show that you've been standing with us during the recession and indeed, our number of supporters has grown. We cannot thank you enough. There will most certainly be fewer grants and less public funding available for conservation for the foreseeable future. The future of beautiful Skagit County depends to a large degree on the foresight and generosity of you and other visionaries who are willing to continue giving so generously. The Trust completed nine conservation projects resulting in 350 acres of land protected. Two of these projects created new Skagit County parks, two protected marine shoreline and rare flora, three protected wildlife habitat for salmon, birds and animals, one conserved the Sumner Lake wetland complex, and one expanded protection of The Anacortes Community Forestlands. The Trust worked with over 20 partners to bring these projects to completion.







STEWARDSHIP

Skagit Land Trust manages 22 conservation areas that it owns and monitors and defends an additional 32 conservation easements. The Trust also restores and provides public access on some land. In the past year the Trust installed three public trails at conservation areas and accomplished numerous stewardship tasks, including: developing property management plans, tree plantings, invasive species control, general property maintenance and ecological inventory data collection. Additionally, we conducted quarterly monitoring of Trust conservation areas and annual monitoring of conservation easements. 635 individuals assisted the Trust in these and other stewardship activities resulting in 3,530 hours of donated time.

These abbreviated financial statements for 2011 are derived from the independent auditor's review submitted to the board of trustees by Jones & Associates LLC, CPAs presenting the financial position of Skagit Land Trust as of March 31, 2011.

FINANCIAL NOTES

- Skagit Land Trust purchased 41-acre Pressentin Ranch for \$244,646. 85% of the funds for purchase came from a grant from the Skagit Recovery Funding Board (SRFB) to protect Chinook salmon habitat. Seattle City Light provided 15% in-kind match.
- 2. 45 acres were added to the Anacortes Community Forest Lands bringing the total protected by conservation easements held by Skagit Land Trust to 1680 acres. For each \$1000 raised by the City of Anacortes for the conservation easement program, Skagit Land Trust receives \$25 per acre for monitoring and enforcement. These funds are restricted to stewardship.
- 3. At Sumner Lake, the Trust purchased 28 acres in a combination of fee land and conservation easement for \$213,041. Funding came from an in lieu of fee settlement and private donations.
- 4. A trail easement was donated by a neighbor of Guemes Mountain; 18 acres were donated to the existing 8-acre Corkery Conservation Easement on Samish Island; The Trust received the Miceli Conservation Easement on Padilla Bay through a bequest. Per industry standards, the Trust does not book a value for donated easements in our financial records.
- 5. The Trust secured \$776,000 of SRFB grant funds and worked with landowners to buy or have donated an additional 179 acres of conservation land. We arranged for other agencies to own these properties. Staff time and due diligence to buy the land are recorded as program expenses but the value of the land itself is recorded with the agency now owning the property.



Over 50 years ago Lee Mann climbed above Cascade Pass and slept under the stars. In the morning hawks were soaring on the ridges, and one lands "...about 10 or 12 feet above my head. And he looked in my eyes, and we had this little exchange. I looked at him and he looked at me, and it seemed to go on for a long time. And finally he's seen enough, and he took to his wings. I thought "That's really amazing!" And I sat up, and here were these beautiful mountains all around, and it was a crystal morning, and a dew had settled overnight, and every blade of grass, every piece of heather was covered with millions and millions of diamonds.

And I was sitting there in this wonderland with millions of diamonds around me! And here I was - I had it all to myself, it was all mine! And suddenly something in my heart just changed. And I knew that my life was going to be different from there on out. I knew that my life was going to have something to do with the mountains."
