## Safety First by Regina Wandler, Stewardship Manager

Safety is a high priority here at the Trust, particularly for those of us heading out to conduct field visits. Trust staff have many procedures we try to follow to reduce risks associated with working outdoors in natural areas, but we are always looking for ways to improve and to create a true culture of safety for both staff and volunteers. Please remember to adopt a safety first outlook by taking the following precautions:

- ◆ Make sure you are prepared for a change in weather – bring appropriate clothing and footwear.
- ◆ Carry a cell phone.
- ◆ If you'll be bushwhacking, wear eye protection.
- ◆ If you'll be doing more than a quick sweep of the parking/access area, carry the 10 essentials with you on your site visits (Washington Trails Association has a good list to refer to!)
- ◆ Invite a trusty field buddy to join you – remember Land Steward Aides have filled out all the paperwork!
  - ◇ If going alone be sure someone (at home or our office) knows when to expect you back from the field.
  - ◇ If you ever have questions about safety or need someone to join you in the field, give us a call!
- ◆ Leave **any situation that feels unsafe** – we can always schedule a follow up visit if needed.

## Field Safety Training Opportunities

We are happy to announce that a grant from Puget Sound Energy will help us achieve some of our safety goals this year. PSE generously donated funding to help staff and volunteers attend Wilderness First Aid (WFA) trainings. I attended a WFA training in October, and learned a great deal about how to handle emergencies in remote natural areas. Though I hope I never have to use most of what I learned, I was glad for the opportunity to hone my skills!

**We are able to offer scholarships to help cover the cost for four Land Stewards to attend a WFA training this year.** Classes are typically about \$250, but you would only pay half the cost (so about \$125). Please contact me if you would like to take advantage of this scholarship opportunity!

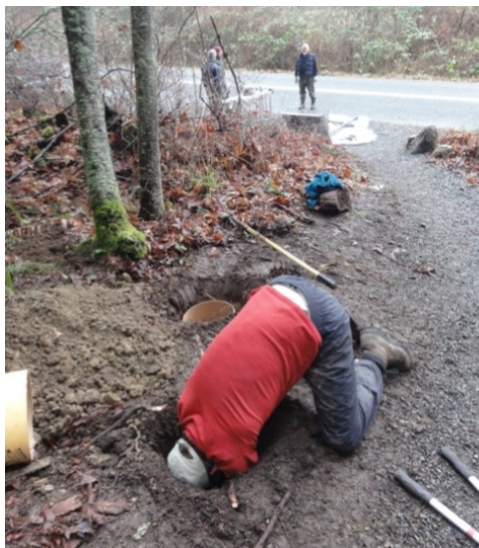
There are WFA trainings scheduled through the spring in nearby locations, including one in **Conway on May 5-6.**

## Reminder about Land Steward Aides

As you may recall, we introduced this additional volunteer position last January, it has been off to a great start. These volunteers are available to join Land Stewards and staff to visit properties for an extra set of hands or if a property is remote and a field partner is needed – always a good idea.

A Land Steward Aide is a volunteer that is not committed to a single property. Land Steward Aides will gain more knowledge about properties than volunteers that join for one-time stewardship events. With this experience, Aides may wish to become Land Stewards of an assigned property when an appropriate location becomes available. Current Land Stewards may contact Aides directly or the office if you need more information. Be sure to look for updated contact info with your next Monitoring Report reminder.

## Transitions by Hannah Williams, Conservation Assistant



On July 16<sup>th</sup>, my position with Skagit Land Trust changed from AmeriCorps Volunteer to Conservation Assistant and official staff member. Along with the new title, my focus has shifted from youth and volunteer outreach, to stewardship and land acquisition. As a Conservation Assistant, I help the land department with our continuous stream of projects, assisting with project development and file management. My position allows me to see a property from start to never ending finish. I help bridge the land and stewardship departments, creating an efficient transition from acquisition to management.

In the stewardship department, I focus on conservation area stewardship, meaning I help ensure that all 38 of our fee owned properties are monitored and cared for. I do this by coordinating with Volunteer Land Stewards to make sure we complete regular monitoring visits and have reports on file. If I can't join you on the ground, your detailed reports tell me where on the property you went, track observations you made, and help paint a picture of your visit. This helps track site changes and property needs over time. I like to think of monitoring reports as writing a lab experiment report. In a lab experiment you write the report as if someone was going to repeat the exact experiment and the same is true for monitoring reports. I also help with many other stewardship tasks, and have helped write management plans for several of the nine properties transferred over from TNC this year.

I wish I could join you all on every visit, but unfortunately there is never enough time. My goal for 2018 is to visit every property at least once and I hope to visit them with you! Thank you all for your hard work and dedication to the Trust and to caring for these amazing natural spaces!
